I am fully aware and acknowledge that horse sports and the participation in the CHJA Medal Finals and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury, including broken bones,					
head injuries, trauma, pain, suffering, or death ("Harm") I AGREE to release the CHJA and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the CHJA and the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the CHJA and the Competition and to hold them harmless with respect to claims for harm to me or my horse, and for claims made by others for and harm caused by me or my horse at the Competition. I have read the Competition Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the CHJA and the Competition strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
