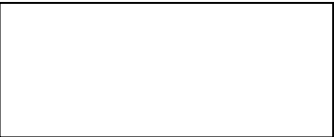

CHJA MEDAL FINALS ENTRY AGREEMENT

I have read the Connecticut Hunter & Jumper Association (CHJA) Rules and Regulations for the CHJA Medal Finals and agree to all of its provisions. I understand and agree that by entering the CHJA Medal Finals, I am subject to all CHJA Rules, regulations, decisions made by the Equitation Committee and local rules of the Competition.

CHJA RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION THIS DOCUMENT WAIVES IMPORTANT LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING

I AGREE in consideration for my participation in the Connecticut Hunter & Jumper Association Medal Finals and Hunter Classics (CHJA) and the Fairfield County Hunt Club (Competition) to the following:
 I AGREE that I choose to participate voluntarily in the CHJA Medal Finals and Competition with my horse, as a rider, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the participation in the CHJA Medal Finals and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering, or death ("Harm")
 I AGREE to release the CHJA and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the CHJA and the Competition.
 I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the CHJA and the Competition and to hold them harmless with respect to claims for harm to me or my horse, and for claims made by others for and harm caused by me or my horse at the Competition.
 I have read the Competition Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the CHJA and the Competition strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
 I agree to waive the right to the use of my photos taken at the CHJA Medal Finals and agree that any actions against the CHJA and the Competition must be brought in the state of Connecticut.
 If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to assume the entire obligation of this Release on the child's behalf.
 I AGREE that The CHJA and the Competition as used above includes all of the officials, officers, directors, employees, agents, personnel, and volunteers. I AGREE that if I am injured at this Competition, the medical personnel treating my injuries may provide information on my injury and treatment to the CHJA.
 I represent that I have the requisite training, coaching and abilities to safely compete in the CHJA Medal Finals and Competition.
